The meeting was called to order by President Steve Eastman. Mrs. Gary gave the Invocation and Mr. Fruge led the Jury in the Pledge of Allegiance.

Mr. Fruge reported the Finance Committee meeting was held on Monday, February 8, 2021 at 7:00 A.M. All bills were reviewed and declared in order with the Committee recommending approval.

It was moved by Mr. Woods, seconded by Mr. Fruge, and carried, to ratify the action of the Agenda Committee in authorizing the State to utilize the Fairgrounds for administering vaccinations for COVID 19 on Monday through Friday between the hours of 7:30 am and 4:30 pm.

Mr. Cormier made the motion, seconded by Mr. LaFargue, and carried, to approve Pay Request No. 11 in the amount of \$15,502.25 to L. K. Breaux & Associates in connection with the Fire District No. 1 new station.

It was moved by Mr. Buller, seconded by Mr. Peterson, and carried, to approve reallocating unused funds from the 2019 Road Improvement project from Division Two to be used for gravel in Division Two.

The motion was made by Mr. Fruge, seconded by Mr. Buller, and carried, to authorize a new Backhoe lease with Doggett Machinery at a cost of \$1,625.00 per month for 48 months for Division Two-One.

Mr. Peterson made the motion, seconded by Mr. Cormier, and carried, to appoint Steve Eastman and Leroy Faul as representatives to the Landfill Commission Board, with Donald Woods and John Marceaux as alternates.

A discussion was held in connection with the LCDBG for Road Improvement program. Mr. Buller reported Alex Guillory has viewed several roads. However, no final decision was made at this time.

Committee Reports

The motion was made by Mr. Woods, seconded by Mr. Talbot, and carried, to "opt-in" to allow on premises consumption of alcohol at bars in the parish, subject to restrictions outlined in the Governor's Proclamation issued on September 11, 2020.

A debris update was given by KDF and TetraTech. Additionally, Mrs. Gary reported the information received from FEMA and GOHSEP states that the parish is not responsible for picking up limbs and branches left behind by utility companies when performing routine maintenance around power lines.

There being no further business to come before the Jury, it was moved by Mr. Woods, seconded by Mr. Peterson, and carried, to adjourn the meeting.
