The meeting was called to order by President Donald Woods. Mrs. Gary gave the Invocation, and Mr. McKnight led the Jury in the Pledge of Allegiance.

Mr. McKnight made the motion, seconded by Mr. Peterson, and carried, to approve the minutes of the meeting held on February 10, 2020, as written and submitted.

It was moved by Mr. Buller, seconded by Mr. Guillory, and carried, to issue a 2020 Ambulance Permit to Acadian Ambulance, with Mr. McKnight abstaining.

The motion was made by Mr. Cormier, seconded by Mr. LaFargue, and carried, to issue a 2020 Ambulance Permit to Med Express Ambulance Service, with Mr. McKnight abstaining.

Ms. Myers made the motion, seconded by Mr. Fruge, and carried, to issue a 2020 Ambulance Permit to Air Evac, with Mr. McKnight abstaining.

It was moved by Mr. LaFargue, seconded by Mr. Cormier, and carried, to reappoint Glen Benoit, Phil Hebert, and Melward Doucet to the board of Welsh Gravity Drainage District No. 1 with terms to expire March 21, 2024.

The motion was made by Mr. Cormier, seconded by Mr. LaFargue, and carried, to ratify the action of the Agenda Committee in authorizing Tuesday, February 25, 2020, Mardi Gras, as a holiday for parish employees.

Mr. Peterson made the motion, seconded by Mr. McKnight, and carried, to approve for Division One: one hundred fifty (150) grader blades at a cost of \$7,870.00.

It was moved by Mr. Fruge, seconded by Mr. Buller, and carried, to approve for Special Revenue: one (1) John Deere 6110M Cab Tractor and one (1) Tiger Bengal Series 22" Mid Mount Mower. LGAP funds of \$11,500.00 will be used toward the purchases.

The motion was made by Mr. Buller, seconded by Mr. LaFargue, and carried, to authorize the payment of Application No. 3 in the amount of \$54,675.00 to Petron LLC, for the Lake Arthur Parish yard project.

Mr. Fruge made the motion, seconded by Mr. Buller, and carried, to authorize the payment of one half (1/2) of the total cost of the Hydro Study for Manuel Road Bridge to be paid by Division Two-One funds. The other one half (1/2) will be paid by Consolidated Gravity Drainage District No. 1. The cost will be \$2,250.00 each.

It was moved by Mr. Fruge, seconded by Mr. Guillory, and carried, to authorize the purchase of four (4) new pickup trucks for the Road Crew Foreman to be paid with Special Revenue funds.


There were no committee reports.
