Mr. Peterson made the motion, seconded by Mr. Marceaux, and carried, with Mr. McKnight abstaining, to adopt the following Ordinance, to-wit:

ORDINANCE NO. 2369

An Ordinance Amending Chapter 10, Health and Sanitation, Article II, Ambulances, Sec 10-15 Definitions, Sec 10-22 Medical Protocols; response times, a.

WHEREAS, the Jefferson Davis Parish Police Jury is empowered to adopt amendments and revisions of its ordinances by Louisiana Revised Statutes.

WHEREAS, the Jefferson Davis Parish Police Jury is desirous of exercising said power; now therefore

BE IT ORDAINED by the Jefferson Davis Parish Police Jury, and it is hereby ordained by the same:

Amend Sec 10-15 Definitions to add the following:

LERN

The Louisiana Emergency Response Network (LERN) is an agency of the state government created by Louisiana legislature in 2004 charged with the responsibility of developing and maintaining a statewide system of care coordination of patients suddenly stricken by serious traumatic injury or time sensitive illness such as heart attack and stroke. It is a system designed to serve as a vital healthcare resource in the event of large-scale emergencies and natural disasters. LA R.S. 40:2841-2846

Amend Sec 10-22 Medical Protocols; response times, (a) to add the following:

- (1) The use of the Louisiana Emergency Response Network
 - This will ensure the proper routing of critically injured and or time sensitive illness to a definitive care facility as defined in LA 40:2841-2846 with signed agreement for participation on Louisiana Emergency Response Network by and between Louisiana Emergency Response network board and the pre hospital agency.

Note: This ensures trauma and time sensitive patients (stroke and heart attack) are routed to the correct facilities capable of treating these patients.

- (b) Response time standards: Any owner or operator of an ambulance service shall adhere to response time standards for defined zones as set by the police jury upon recommendation of the Jefferson Davis Parish local Ambulance Regulatory Committee.
 - (1) Response Zones
 - Urban Zone
 - The city limits of Jennings
 - Suburban Zone
 - 12 Mile radius from the center of Jennings
 - Rural Zone
 - All areas within the parish but outside of the above mentioned zones
 - (2) Response Times
 - Urban Zone
 - o Within 8 minutes Equal to or less than 8:59
 - Suburban Zone
 - o Within 15 minutes Equal to or less than 15:59
 - Rural Zone
 - Within 22 minutes Equal to or less than 22:59

Note these distances are computed with the average posted speed limits not to exceed 75 mph. for all zones.

Response times shall start when the call is placed in que by the receiving ambulance services call taker or dispatcher. Ambulance services shall be held to 80% on time rate for each zone. Failure to meet the 80% requirement is subject to review by the ambulance committee and may result in fines as listed in subsection 10.23.5d

Example: 100 calls in the urban zone, 80 of the calls must have a unit on the scene in less than 8 minutes 59 seconds in order to be in compliance.

Any call in the Urban Zone that exceeds 12 minutes will be subject to review by the ambulance committee and may result in fines as listed in subsection 10-23.5.d

Any call in the Suburban Zone that exceeds 23 minutes will be subject to review by the ambulance committee and may result in fines as listed in subsection 10-23.5.d

Any call in the Rural Zone that exceeds 33 minutes will be subject to review by the ambulance committee and may result in fines as listed in subsection 10-23.5.d

An Ordinance Amending Chapter 10, Health and Sanitation, Article II, Ambulances, Sec 10-23.1 Daily logs and records.

WHEREAS, the Jefferson Davis Parish Police Jury is empowered to adopt amendments and revisions of its ordinances by Louisiana Revised Statutes.

WHEREAS, the Jefferson Davis Parish Police Jury is desirous of exercising said power; now therefore

BE IT ORDAINED by the Jefferson Davis Parish Police Jury, and it is hereby ordained by the same:

Amend Sec 10-23.1 Daily logs and records to add the following:

- (c) Monthly reports
 - (1) The ambulance service/services shall provide a monthly report to the Jefferson Davis Parish Police Jury by the 10th of the month on all emergency response times during the previous month. In the exception section they shall explain why the ambulance service was in excess of their required time limits as listed in section 10:22.b. Each owner or operator shall retain and preserve all time reports and recordings for at least twelve (12) months, and such reports and recordings shall be available for inspection by the parish.
 - (2) Monthly Report Requirements
 - (a) Each owner operator who is granted an ambulance permit by the parish shall maintain a response time report, upon which shall be recorded the following information as indicated.
 - (1) Division: Jefferson Davis Parish
 - (2) Area: Indicates which zone the call falls under. i.e. Urban Zone 8 minutes, Suburban Zone 15 minutes, Rural Zone 22 minutes.
 - (3) Date: Indicates the date of service
 - (4) Response Number: Indicates the call number given to the call by the ambulance service.
 - (5) Origin Name: Indicates the name of the location. i.e. nursing home, name of business.
 - (6) Origin Address: Indicates the address of the location
 - (7) Origin City: Indicates the name of the city the call originated in
 - (8) Origin Zip Code: Indicated the zip code of the response
 - (9) Call in Que: Indicates when the ambulance service received the call. Formatted in hours:minutes:seconds
 - (10)Call Taking Complete: Indicates when the call taker completed taking the information on the call. Formatted in hours:minutes:seconds
 - (11)At Scene: Indicates the time the ambulance assigned to the call arrived on scene at the patient's location. Formatted in hours:minutes:seconds.
 - (12)Response time: Indicates total response time. Formatted in hours:minutes:seconds.
 - (13)Priority: Indicates the priority of the call as assigned by the dispatcher.
 - (14)Chief Complaint: Indicates the type of emergency call (what is the patient's complaint)

- (15)Caller Type: Indicates nursing facility, employee, patient, family member, so on.
- (16)Call Back Phone Number: Indicates the phone number the call was received from.
- (17) Cancel Reason: Indicates the reason for cancelling the response.
- (18) Destination: Indicates the destination the patient was transported to.
- (19) Destination City: Indicates the city the patient was transported to.
- (20) Transports: Indicates whether or not the patient was transported.
- (b) Timely Rollover Calls -When two or more ambulance providers are operating in Jefferson Davis Parish, each ambulance provider shall notify the Jefferson Davis Parish Police Jury by the 10th of each month the number of calls they received from Jefferson Davis 911 and the number of emergency calls they had to roll over to another provider for the previous month.

(d) Exceptions

- (1) The parish police jury agrees that the delayed response which was no fault of the ambulance service shall not be deemed the fault of the ambulance service and shall not be penalized.
- (2) List of authorized exceptions
 - (a) Faulty address data or insufficient information from the caller.
 - (b) Response during periods of abnormally severe weather that could substantially impair response times.
 - (c) Unusual road conditions, blocked bridges, railroad crossings that could substantially impair response times.
 - (d) Prank calls
 - (e) Three (3) emergency calls to the same service simultaneously in progress within Jefferson Davis Parish. The exception starts after the second call.
 - (f) Declared Disaster
- (30 Unit 10-97 (on-scene) will not be allowed as an exception unless C.A.D. (Computer Aided Dispatch) A.V. L. (Automatic Vehicle Locater) or GPS data can be provided.

The ambulance service failing to meet the deadlines listed above in section 10-23.1 shall be reviewed by the ambulance regulatory committee and subject to penalties as listed in section 10-23-5.

Amend Sec 10-23.2 Enforcement Authority to change (b) to:

- b) The Ambulance Regulatory Committee shall oversee all aspects of the ambulance ordinance, regulation and penalties of any and all ambulance providers holding a permit in the parish.
- Their recommendations will be sent to the full police jury for a vote.

An Ordinance Amending Chapter 10, Health and Sanitation, Article II, Ambulances, Sec 10-23.5 Penalties and violations.

WHEREAS, the Jefferson Davis Parish Police Jury is empowered to adopt amendments and revisions of its ordinances by Louisiana Revised Statutes.

WHEREAS, the Jefferson Davis Parish Police Jury is desirous of exercising said power; now therefore

BE IT ORDAINED by the Jefferson Davis Parish Police Jury, and it is hereby ordained by the same:

Amend Sec 10-23.5 Penalties and violations to add the following:

- (d) Penalties and fines
 - (1) Any ambulance service found in excess of the thresholds outlined in section 10.22.b can be fined up per occurrence. Monthly reports to the Jefferson Davis Parish Police Jury shall be reviewed by the Ambulance Regulatory Committee Chairman.
 - (2) Any ambulance service found to be in violation of any section of this ordinance can be fined up per occurrence.
 - (a) First Offense

Written warning outlining the offense

(b) Second Offense within one year

Shall receive \$500 fine with written warning outlining the offense

(c) Third Offense within one year

Shall receive a \$1000 fine and temporary revocation of permit pending ambulance regulatory committee review

(3) If an ambulance service is found in repeated offense of these response times as stated in section 10-22.b, it gives grounds to the parish police jury to suspend or terminate the issued permit as stated in section 10-23.3. The parish police jury also agrees that the delayed response which was no fault of the ambulance service shall not be deemed the

fault of the ambulance service (reference section 10-23.1 Exceptions) and shall not be penalized.

Amend Sec. 18-1.1, a. Plat Recordation and Exceptions to add the following:

- 2. All Minor and Small Subdivision Plats shall include the following:
 - A. The subdivision name, the names and addresses of the owners, and of the designer of the plat, who shall be a registered land surveyor.

B. Date, approximate north point, and graphic scale.

- C. Sketch of location's drainage path from the proposed subdivision to the Gulf of Mexico.
- D. 5' private drainage easement shall be included and annotated at all side and rear lot lines.
- E. Subdivision lots fronting public roads shall reserve a minimum 30' public road right of way and 15' drainage and utility easement.

An Ordinance Amending Chapter 18, Sec. 18–16, a.1.i, a.1.ii Drainage, Specification Generally, Sec 18-16, a.7, Drainage, and Sec 18-16, a.8., Drainage.

WHEREAS, the Jefferson Davis Parish Police Jury is empowered to adopt amendments and revisions of its ordinances by Louisiana Revised Statutes.

WHEREAS, the Jefferson Davis Parish Police Jury is desirous of exercising said power; now therefore

BE IT ORDAINED by the Jefferson Davis Parish Police Jury, and it is hereby ordained by the same:

Amend Sec. 18-16, a.1 Design or construction to be revised to add:

i. Drainage Impact Analysis (DIA) for Major Subdivisions. A DIA is required for all new Major subdivision developments, and all new commercial and industrial site developments requiring a building or grading permit. Said DIA shall be submitted to the Jury for review and approval, with cover page of said DIA signed and sealed by a licensed Louisiana civil engineer. No development shall be approved for construction without an approved DIA or obtaining a waiver. The DIA must receive the parish engineer or designee's review and approval before any development improvements begin.

1. General Requirements:

a. The Drainage Study shall document proof of no negative drainage or flooding impact from the proposed development to adjacent or nearby properties for the design storm events

b. No portion of a watershed shall be diverted to an adjacent watershed

unless approved by the parish engineer

c. The Jeff Davis Parish Police Jury reserves the right to request additional information at any time outside of these published ordinance requirements

2. Submittal Requirements

- a. Cover page signed and sealed by Louisiana-licensed civil engineer
- b. Report narrative which includes at minimum:
 - 1. executive summary
 - 2. description of development
 - 3. description and name of local flooding source
 - 4. description and methodology supporting the calculated Base Flood Elevation, if site does not lie within regulatory Zone AE flood zone
 - 5. regional watershed size and description
 - 6. development impacts and proposed method of mitigation.
- c. Maps. All Maps shall include scale, north arrow, legend and title block, delineated watershed boundaries, longest flow paths, watershed slopes with time of concentration, and FEMA regulatory flood zones (if applicable.)

1. Regional watershed map, if applicable. Shall include the watershed boundary within which the development sites lie. This requirement generally applies if the flooding source for the development site is a drainageway with a larger, upstream contributing watershed.

2. Pre-development (existing) drainage map. Include watershed delineations for all existing drainage and stormwater structures in the project's vicinity such as cross drains, bridges, channel

confluences etc.

3. Post-development (proposed) local drainage map. Include watershed delineations for all existing drainage and stormwater structures which will remain in-place and affect drainage of the proposed development as well as delineations for drainage and stormwater structures proposed as part of the development such as culvert, cross drains, bridges, detention ponds, etc.

d. Water Surface Profiles. These shall be computed for any flooding sources passing through or adjacent to development site, with a contributing area at any point adjacent to the proposed development site greater than 200 acres. Sheets shall be plan and provide format

with max scale of 1" = 40

1. Pre development(existing) profile. Shall be based on field collected topographic data of the open channel and include existing structures such as cross drains, bridges, and subsurface items (pipeline, etc.)

2. Post development (proposed) profiles. Shall be based on field collected topographic data of the open channel and engineered data as required. Profile calculations and deliverables shall include existing and proposed structures such as cross drains, bridges, and

subsurface items (pipeline, etc.)

e. Calculations and Results. Report shall include such tables and other maps, sketches, hand calculations, model output tables, etc. as are necessary to describe the analysis results which detail no negative drainage or flooding impact from the proposed development to adjacent or nearby properties for the design storm events

f. Construction Plan Sheets. Report shall include construction drawings of roads, detentions ponds, channels, site grading, erosion protection, etc. Roads and channels shall include plan, section and profile views; detention ponds shall include plan and section views; erosion protection sheets shall include plan sheets with item details

ii. Runoff Calculations. Peak runoff shall be calculated in accordance with the DOTD Hydraulics Manual latest edition with the following amendments. Runoff hydrographs shall be developed using a 24-hour storm event and curvilinear modes (SCS Unit Hydrograph is commonly used).

1. Design storms

- a. Channels- 10 year. Drainage channels shall accommodate one foot of freeboard for the 10-year event. The 100- year storm event shall also be analyzed and documented in the DIA. Both 10 and 100-year hydraulic grade lines (HGL) shall be shown on the required water surface profiles (Section 18-16 (1)(i)(2)(d).
- b. Roadside Ditches 5 year. Roadside ditches shall contain the HGL below the edge of road for the 5-year event.
- c. Detention Ponds see Sec 18-16, a,8
- **2. Hydraulics Calculations.** Hydraulic performance shall be calculated in accordance with the DOTD Hydraulics Manual latest editions with the following amendments.

a. Detention ponds - see Section 18-16 (a) (8)

b. Site Grading. Site grading shall achieve a minimum of 0.5% slope from all points of the proposed development to a public drainage channel, roadside ditch, or catch basin.

Amend Sec 18-16, a. 7 to be revised to read:

7. Drainage. In the design of the drainage for the subdivision, provision shall be made to adequately take care of adjacent watershed areas after they have been developed. All drainage structures should be sufficient for the drainage of the watershed after complete development of the area; and where ditches and canals are used, a minimum drainage and maintenance servitude of 20' shall be provided with access to a public right of way provided.

Amend Sec 18-16, a, to be revised to add:

8. Detention Design. Small and Major Subdivisions shall be required to mitigate the 10 year rain event runoff to pre-development conditions. The most common way is with surface detention but other methods such as subsurface detention shall be considered. Other requirements:

a. Detentions structures shall also be designed to pass the 100 year storm event

without breaching of pond berms or levees.

b. In-line detention within an existing named drainage channel shall not be allowed.

c. A minimum 5 foot of clearance shall be provided around all detention ponds and structures measured from outer toe of berm, edge of spillway, or other appurtenances of the pond.

d. Pond side slopes shall be no steeper than 3H:1V

e. Pond stormwater releases shall utilize a reinforced concrete control structure.

f. Required calculations:

1. A stage-storage and stage-discharge relationship for the pond

2. The development inflow hydrographs for the required storm events (25 and 100 year). Inflow hydrographs shall be developed using the methods specified herein.

The routing calculations and outflow hydrographs for the required storm events

4. All necessary outlet structure details, including detailed engineering construction drawings and specifications with reference to mean sea level elevations at invert and overtopping locations, for the structure. Weir coefficients and/or friction coefficients shall be provided if applicable

g. Ponds shall be maintained by developer and / or homeowners associations.

Jefferson Davis Parish Police Jury shall not maintain retention/detention

ponds.

Mr. McKnight reported an OEP Committee meeting held on Wednesday, March 31, 2021 at 5:30 p.m. The Committee received a Letter of Resignation from Sheriff Ivy Woods effective May 1, 2021. The OEP Committee recommends appointing Angie Theunissen as Interim OEP Director effective May 1, 2021 until December 31, 2021.

The motion was made by Mr. McKnight, seconded by Mr. LaFargue, and carried, to accept the OEP Committee's recommendation.

There being no further business to come before the Jury, it was moved by Mr. Guillory, seconded by Mr. Peterson, and carried, to adjourn the meeting.
