The Police Jury entered into a Contractor Agreement with Horace Doucet in 2007 for maintenance of the Roanoke Park. Since Mr. Doucet is no longer able to perform these duties, his daughter Olita Green has requested replacing him. It is the recommendation of the Finance Committee to send a letter to Mr. Doucet cancelling his services and further entering into a new Independent Contractor Agreement with Ms. Green.
