The meeting was called to order by President J. Steven Eastman. Mr. David Bruchhaus gave the Invocation, and Mr. Adams led the Jury in the Pledge of Allegiance.

Mr. Marceaux reported that the Finance Committee met on Monday, August 9, 2021, at 7:00 A.M. The Finance Committee recommends hiring Bin There LLC to remove the tree on the adjudicated property on Doyle St at a cost of \$3,800.00.

Mr. Marceaux made the motion, seconded by Ms. Myers, and carried, to accept the recommendation of the Finance Committee.

Additionally, the Finance Committee recommends authorizing the Secretary to advertise to replace the Courthouse Custodian.

The motion was made by Mr. Marceaux, seconded by Mr. Guillory, and carried, to accept the recommendation of the Finance Committee.

Finally, Mr. Marceaux reported the Committee recommends paying KDF Enterprises \$500,000.00 for debris cleanup services after Hurricane Laura and Delta out of Special Revenue Funds.

It was moved by Mr. Marceaux, seconded by Mr. Fruge, and carried, to accept the recommendation of the Finance Committee.

Ms. Myers made the motion, seconded by Mr. McKnight, and carried, to pay DRC Emergency Services \$500,000.00, Thompson Consulting \$50,000.00 and Tetra Tech \$100,000.00 out of Special Revenue Funds for services rendered after Hurricane Laura and Delta.

The motion was made by Mr. Adams, seconded by Ms. Myers, and carried, to keep a reserve of \$750,000.00 in the Special Revenue account.

Tim McKnight reported that the OEP Committee met August 11, 2021 at 5:15 pm. The Committee recommends purchasing 11 Motorola Radios with OEP Grant Funds.

It was moved by Mr. McKnight, seconded by Mr. LaFargue, and carried, to accept the recommendation of the OEP Committee.

Mr. LaFargue made the motion, seconded by Mr. Buller, and carried, to advertise in connection with the RFP process in regard to procuring qualified consulting services to provide Disaster Management, Recovery, and Emergency Management Services for the Jury as relating to FEMA, Louisiana PA, and Louisiana Hazard Mitigation.

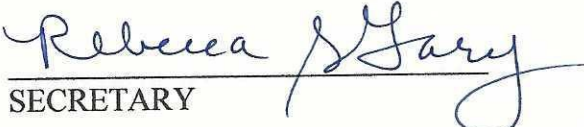
