The Finance Committee recommends making the change to the Courthouse Pay Scale as presented.

It is the recommendation of the Finance Committee to make the change to the Office Pay Scale as presented.

It was moved by Mr. Marceaux, seconded by Mr. Peterson, and carried, to accept the recommendation of the Committee as presented. Ms. Myers voted against the matter.

Finally, it is the recommendation of the Finance Committee to make the following payments: DRC - \$115,131.88 and KDF - \$100,000.00.

It was moved by Mr. Woods, seconded by Mr. Buller, and carried, to ratify the action of the Agenda Committee in approving the bid from L & R Construction in the amount of \$23,754.00 for the Lyons Road Bridge repair and to further authorize Bluewing Civil to issue a Notice of Award. Nick Johnson noted the date on the second page will be amended to May 11 instead of December 11.

Mr. Fruge made the motion, seconded by Mr. Buller, and carried, to ratify the action of the Agenda Committee in approving Change Order No. 1 from L & R Construction for an increase of \$10,495.84 in connection with the Manuel Road Bridge repair.

It was moved by Mr. Peterson, seconded by Mr. McKnight, and carried, to ratify the action of the Agenda Committee in adopting the following Proclamation, to-wit:

President Eastman recused himself and the matter was turned over to Vice President Guillory. No public comments were received. There was a motion and second. However, both were withdrawn since the owners were not at the meeting to answer questions regarding whether a turning lane would be required along Hwy 26. The matter was postponed.

It was moved by Mr. Peterson, seconded by Mr. Woods, and carried, to authorize the Secretary to advertise in connection with semi-annual supplies.

Mr. Marceaux made the motion, seconded by Mr. Adams, and carried, to authorize Bluewing Civil to solicit bids in connection with the repair of sink holes on Woodland Drive.

The motion was made by Mr. Talbot, seconded by Mr. Cormier, and carried, to ratify the action of the Agenda Committee in approving a 6-month trial period membership with IMCAL.

- WHEREAS, The Jefferson Davis Parish Police Jury developed Plan A1 as the new election plan for the members of the Jefferson Davis Parish Police Jury that was in fulfillment of the requirements of Section 2 of the Voting Rights Act, the requirements of the State of Louisiana, and the Louisiana Secretary of State, and:

new whole precincts are created from the precinct splits contained in the Reapportionment Plan and redescribes the remaining precincts as hereby described to wit in the attached Exhibit A.
