WHEREAS, the code of Federal Regulations as enacted by the United States Congress mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity and posted in accordance with the National Bridge

Inspection Standards and that an inventory of these bridges will be maintained by each state; and

WHEREAS, the responsibility to inspect, rate, and load post those bridges under the authority of Jefferson Davis Parish in accordance with those Standards is delegated by the Louisiana Department of Transportation and Development to Jefferson Davis Parish,

NOW THEREFORE BE IT RESOLVED, by the Police Jury of Jefferson Davis Parish, Louisiana, (herein referred to as Parish) convened in Regular Session on the 11th day of October, 2023, that it does hereby certify to the Louisiana Department of Transportation and Development (herein referred to as the DOTD) that for the period of January 1, 2023 through December 31, 2023:

- 1. The Parish has performed and will continue to perform all interim inspections on all Parish-owned or maintained bridges in accordance with the National Bridge Inspection Standards;
- 2. All bridges owned or maintained by the Parish have been structurally analyzed and rated by the Parish as to the safe load capacity in accordance with AASHTO Manual for Maintenance Inspection of Bridges. The load posting information that has been determined by the LA DOTD for all bridges where the maximum legal load under Louisiana State law exceed the load permitted under the operational rating, as determined above, has been critically reviewed by the Parish. Load posting information has been updated by the Parish to reflect all structural changes and obsolete structural ratings or any missing structural ratings;
- 3. All Parish-owned or maintained bridges which require load posting or closing are load posted or closed in accordance with the table in the DOTD Engineering Directives and Standards Manual Directive No. 1.1.1.8. All DOTD supplied load posting information concerning a bridge has been critically reviewed by the Parish Engineer prior to load posting; and
- 4. All bridges owned or maintained by the Parish are shown on the attached list in the format specified by the LA DOTD. Corrections to date supplied to the Parish by the LA DOTD are noted.
