The meeting was called to order by President Steve Eastman. Mrs. Landry gave the Invocation and Mr. McKnight led the Pledge of Allegiance.

Note: The following comments were received during the agenda meeting held on October 1, 2025. These comments were not discussed during the October 8, 2025, regular meeting.

During the agenda meeting held on October 1, 2025, Ms. Jackie Brown, representing the Jefferson Davis Parish Volunteers for Family & Community (VFC), addressed the Police Jury with a request for a Cooperative Endeavor Agreement between the Police Jury and the VFC. The agreement would provide for the use of the William E. Broussard Multi-Purpose Building, Fairgrounds, and Arena for the Louisiana VFC Convention, scheduled to be held in April 2026. The CEA is scheduled for consideration and vote at the Police Jury Meeting on October 8, 2025.

During the agenda meeting held on October 1, 2025, Mrs. Kristi Howard, a resident of Gro Racca Road, voiced a public complaint regarding a neighboring property. She reported that the property contains multiple Conex boxes and that metal structures are being moved on and off the site. Mrs. Howard expressed concern about the potential negative impact on surrounding property values and requested that the Police Jury investigate the issue. Mr. LaBouve responded, stating that he had visited the property approximately three weeks prior. He noted that the property owners purchased the land during the summer of 2025, and it appears they are fabricating, welding, and

transporting materials off-site. Mr. Boudreaux also noted that he visited the property on or about September 8, 2025, and took photographs. He stated that the Police Jury is continuing to monitor the property, but at this time, there is no clear evidence of a violation that would warrant formal action. Mr. James Willard, another resident of Gro Racca Road who lives west of the subject property, also addressed the Jury. He stated that there appear to be two welders actively fabricating square covers on-site. He expressed additional concerns, claiming that the property lacks water and electricity, and that the owners are sandblasting A-frame type covers. Mr. Person advised the public that landowners can challenge zoning classifications in court, if necessary. To continue the dialogue, Mr. Boudreaux stated he would reach out to the landowners and invite them to speak with the Police Jury regarding their activities on the property.

Public Comments – Police Jury Meeting October 8, 2025

Cesilee Oliver, Director of Economic Development, provided an update on several ongoing projects and grant initiatives that are expected to have a significant positive impact on the Jefferson Davis Parish community. She reported that several properties have been certified as "shovel ready," positioning them for future development opportunities. In addition, property owners have expressed support for re-zoning their land from Agricultural to Industrial use to better align with future development goals. In response, the Police Jury recommended that Ms. Oliver contact the landowners directly to initiate the re-zoning process, facilitating a smoother transition and readiness for upcoming industrial projects.

Developer Salman Chaudhry spoke to the Police Jury regarding significant roadblocks hindering investment and development along the I-10 and Hwy 395 Corridor in Jefferson Davis Parish. He emphasized that the lack of utility infrastructure remains a critical barrier, causing potential developers to hesitate on moving forward with projects in the area. To address funding challenges and support necessary infrastructure improvements, Mr. Chaudhry proposed that the Police Jury consider including existing businesses within the region in the Economic Development District (EDD). This approach, he noted, would allow the parish to begin generating revenue from current businesses while awaiting future development, helping to finance essential services and encourage growth.

Larry Myers, a property owner, addressed the Police Jury concerning an ongoing issue with a neighboring tenant of farmland who has been pulling mud onto the road. Mr. Myers presented photographs and water samples as evidence. He mentioned that he had previously attended a Police Jury meeting to raise this concern but had not received any follow-up communication. Mr. Myers expressed worry about the hazards posed to drivers, particularly after rainfall, and the damage the mud is causing to the road.

In response, Mr. Boudreaux stated that after the initial complaint, he inspected the road and found it to be in normal condition, noting that sand and gravel are naturally present on local roads. Mr. Fruge commented that these are farming communities where mud on roads is a natural consequence of allowing farmers to transport their crops. He had spoken with the farmer, who assured him that efforts would be made to maintain the road. President Eastman added that farmers have a right to farm and transport their crop. Mr. Myers inquired whether there is an existing ordinance addressing mud on roads. Mr. Person responded that he would research relevant ordinances and state laws and provide an update within the next several weeks.

Staci Thibodeaux, owner of Grace Ranch in Hathaway, LA, was invited to address the Police Jury and respond to questions regarding the ranch's business activities related to the sale of milk and beef. Mr. Boudreaux encouraged Ms. Thibodeaux to work with the Police Jury to ensure the business is in compliance with local zoning regulations. Ms. Thibodeaux stated that Grace Ranch operates as a Farm to Table business and believes the current Agricultural Zoning designation is appropriate for their operations. She clarified that no beef processing is conducted on-site; instead, all processing is performed at a licensed off-site facility. She also confirmed that their beef is registered with the USDA. Ms. Thibodeaux explained that their products are pre-sold, and customers pick up orders at a farm building and roadside stand located on the property. She emphasized that the business operates in line with the Right to Farm Act and traditional farming practices. Mr. Lafargue asked whether the business is registered to pay taxes to the parish. Ms. Thibodeaux responded that they are exempt from state tax under current regulations. President Eastman assured Ms. Thibodeaux that the Police Jury is supportive of agricultural operations like Grace Ranch and expressed the Jury's willingness to work collaboratively to develop an ordinance that appropriately supports and regulates Farm to Table businesses within the parish.

Mr. Lafargue reported the Finance Committee meeting was held on October 6, at 7:00 A.M. All bills were reviewed and declared in order with the Committee recommending approval.
