WHEREAS, the Jefferson Davis Parish Police Jury Section 8 Program uses the published FMR's as a guide to establish FMR's per bedroom size for the Housing Choice Voucher Program; and

WHEREAS, the Section 8 Program may establish Payment Standards anywhere between 90 and 110 percent of the published FMR without obtaining HUD approval; and

WHEREAS, the Payment Standards are used to calculate the housing assistance payment (HAP) that the PHA pays to the owner on behalf of the family leasing the unit; and

WHEREAS, the Payment Standard set by the Section 8 Program affects the amount of subsidy a family will receive and the amount of rent that will be paid by the tenant; and

WHEREAS, the Jefferson Davis Parish Police Jury Section 8 Program must also determine that its annual budget for the Housing Choice Voucher Program will support the established payment standard; and

WHEREAS, the Jefferson Davis Parish Police Jury Section 8 Program must also ensure that the program participants will be able to find safe, decent, and affordable units within the program's jurisdiction within the standards established; and

WHEREAS, the Jefferson Davis Parish Section 8 Program has determined the Payment Standard shall be 110% for all bedroom size units.

RESOLUTION

ANNUAL CERTIFICATION OF COMPLIANCE WITH STATE OF LOUISIANA OFF SYSTEM BRIDGE REPLACEMENT PROGRAM.

WHEREAS, the code of Federal Regulations, as enacted by the United States Congress, mandates that all structures defined as bridges located on all public roads shall be inspected, rated for safe load capacity, and posted in accordance with the National Bridge Inspection Standards, and that an inventory of these bridges will be maintained by each state; and

WHEREAS, the responsibility to inspect, rate, and load post those bridges under the authority of Jefferson Davis Parish, in accordance with those Standards, is delegated by the Louisiana Department of Transportation and Development to Jefferson Davis Parish,

NOW THEREFORE BE IT RESOLVED, by the Police Jury of Jefferson Davis Parish, Louisiana, (herein referred to as Parish) convened in Special Session on the 22nd day of October, 2025, that it does hereby certify to the Louisiana Department of Transportation and Development (herein referred to as the DOTD) that for the period of January 1, 2026 through December 31, 2026:

- 1. The Parish has performed and will continue to perform all interim inspections on all Parish-owned or maintained bridges in accordance with the National Bridge Inspection Standards and Specifications for the National Bridge Inventory.
- 2. All bridges owned or maintained by the Parish have and will continue to be structurally analyzed and rated by the Parish as to the safe load capacity in accordance with American Association of State Highway and Transportation Officials (AASHTO) Manual for Bridge Evaluation. The load posting information that has been determined by DOTD for all bridges where the maximum legal load under Louisiana State law exceeds the load permitted under the operating rating, as determined above, has and will continue to be critically reviewed by the Parish. Load posting information has and will continue to be updated by the Parish to reflect all structural changes, and obsolete structural ratings, or any missing structural ratings.

- 3. All Parish-owned or maintained bridges which require load posting or closing are and will continue to be load posted or closed in accordance with the table in the DOTD Load Rating Directives. All DOTD supplied load posting information concerning a bridge has been critically reviewed by the Parish Engineer prior to load posting.
- 4. All bridges owned or maintained by the Parish are shown on the attached list in the format specified by the DOTD. Corrections to data supplied to the Parish by the DOTD are noted.
- 5. All bridges owned and maintained by the Parish are accessible to DOTD for all routine bridge inspections. Parish will clear vegetation as required upon DOTD request.

These stipulations are prerequisites to participation by the Parish in the Off-System Bridge Replacement Program.
